#### **DIRECTIONS:**

**Highway 7 and Highway 85 intersection.** Proceed East on Highway 7 (also known as Bridge St. through Brighton). When you get to the intersection of Bridge St. and 27<sup>th</sup> Avenue, turn right on 27<sup>th</sup>. Follow 27<sup>th</sup> all the way to Purcell Street. You will see the building on the left hand side of the street.

**I-76 and Bromley Avenue:** Proceed West on Bromley Avenue to 27th Avenue. Turn Right or North on 27th Avenue. The building is on Purcell. You will see the building on the right hand side of the street.
